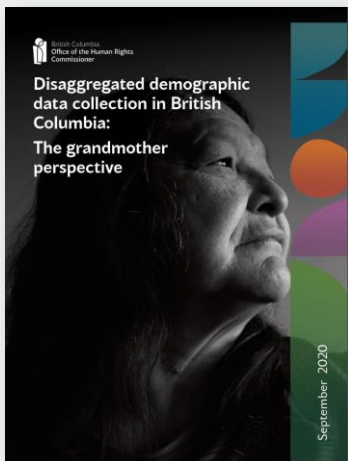

She is passionate about using her skills as a lawyer and community builder to create a more equal and just province.

**Trish Garner** (they/ them/ theirs) is a tea-swilling Brit with a passion for social justice. Having gained their experience at the Canadian Centre for Policy Alternatives and working with Raise the Rates, an anti-poverty group based in the Downtown Eastside of Vancouver, they led the BC Poverty Reduction Coalition for eight years before joining BC Office of the Human Rights Commissioner.
